## **POSITION SUMMARY**

At Skylight Mental Health we are passionate about supporting NDIS Participants by delivering a range of recovery-oriented community mental health services. We do this by working alongside people experiencing mental health issues, family and friends who support them, and the broader general South Australian community. Skylight develops programs with input from participants to ensure responsive, effective services that build on strengths, increase resilience and improve mental health.

Skylight services include individual support, carer programs, therapeutic groups, social and recreational activities, education, information, advice and referral. These are designed to help people get the support they need so their skills and independence improve over time.

Skylight is the SA member of the national advocacy peak body MIFA (Mental Illness Fellowship Australia)

The Psychosocial Recovery Coach functions under the overall guidance of the supervisor, who offers direction and supervision. The Psychosocial Recovery Coach will provide individualised recovery coaching supports to NDIS Participants supporting them with their journey of recovery towards leading a contributing and fulfilling life. You will assist participants to achieving the goals set out in their NDIS plans through a recovery based approach.

### **SPECIAL CONDITIONS**

The position may require flexible work hours. Flexible work hours are subject to the needs of the program, as negotiated with the Supervisor with time off in lieu provided by mutual agreement where additional hours are worked, to maintain an average of allocated hours per week.

DHS Working with Children check and NDIS Worker Check are required prior to appointment. You must hold a Permanent Resident Visa or be an Australian Citizen to apply for this position.

The Psychosocial Recovery Coach may be required to use their own registered, insured and fully maintained motor vehicle for work purposes and will be compensated for mileage at the Award rate.



## **DUTIES**

- Use a strength-based and person-centred recovery approach to build skills, capacity and independence of participants, ensuring participant goals and choices drive the process of engaging supports
- Working with participants to develop a recovery enabling relationship
- Deliver all services according to Skylight Service Standards, which align with national recovery oriented mental health standards
- Work collaboratively with participants to link into community, mainstream and other government services
- Actively provide support to assist participants to prepare for plan reviews as required
- Maintaining an up to date knowledge of the NDIS systems and practices
- If appropriate, use lived experience of mental illness appropriately and for the benefit of Skylight participants
- Maintaining accurate and up to date documentation: including case notes, billing (Service Delivery Entries), progress reports, and other Skylight Psychosocial Recovery Coach documentation as required
- Assessing and managing risk in line with Skylight's organisational policies and procedures
- Contribute to the high standard of service provided by Skylight by participating in relevant meetings and supervision consistent with Skylight's strategic plan, policies and procedures and contributing to continuous quality improvement activities
- Plan, develop and implement special projects and events as directed by the CEO or delegate to meet specific and identified needs. This may include working within or alongside other Skylight Programs/Work Areas from time to time to achieve Skylight's strategic goals



## SELECTION CRITERIA

### Skills, Knowledge and Experience

- Minimum Certificate IV in Mental Health or Certificate IV in Mental Health Peer Work and/or two years experience in mental health related work
- Demonstrated knowledge and understanding of psychosocial disability and recovery, including trauma informed practice and supported decision making
- Excellent interpersonal skills, be non-judgmental, patient, willingness to listen and display empathy
- Demonstrated ability to engage with participants to build a trusting coaching relationship that motivates and builds the participant's capacity to set goals
- Ability to facilitate access and coordination of community resources, services and other government service systems
- Effective time management, balancing workload, and prioritising to achieve the agreed minimum billable KPI
- Show demonstrable knowledge and application of the NDIS and NDIA legislation and other statutory requirements
- (Desirable) Lived experience of mental health recovery and excellent skills in appropriate use in the support of Skylight customers and participants
- Current SA Drivers License and willingness to use own registered, insured (at a minimum Third Party Property Damage Insurance) and fully maintained motor vehicle for work purposes
- Current Introduction to First Aid and Child Safe Environment accreditation (or willingness to obtain)
- Good knowledge of Microsoft Office Programs, CRM databases, email and internet
